HAJ 2022

The Haj pilgrims visit Makkah and Madinah in Kingdom of Saudi Arabia and the duration of the complete tour stretches to 40-45 days. Ministry of Minority Affairs is vested with the responsibility of making overall arrangement for Haj and its supervision. Haj Committee of India (HCoI) a statutory body of Ministry of Minority Affairs, with assistance of State Haj Committees (SHC) make arrangements for pilgrims in India. Consul General of India, Jeddah (CGI) makes arrangements in the Kingdom of Saudi Arabia. Ministry of Health arranges the vaccines. Ministry of Civil Aviation arranges air transportation of pilgrims.

- 2. Government of India fixes the Quota (Number of Pilgrims) of Haj Committee every year in terms of the bilateral Agreement with Kingdom of Saudi Arabia. For Haj- 2022 Quota fixed for HCoI is 56601 pilgrims.
- 3. This year, the Haj Charter flights operation is being carried out through Ten (10) Embarkation points in the Country. The Government makes all effort to ensure that Hajj Operations are carried out efficiently and all convenience is provided to the pilgrims. In Haj- 2022 the following three airlines have been selected through tender process:
 - Saudi Arabian Airlines for 08 embarkation points: Ahmadabad, Bangaluru, Cochin, Delhi, Hyderabad, Kolkata, Lucknow, Mumbai
 - Flynas for 01 embarkation point: Guwahati
 - Spicejet for 01 embarkation point: Srinagar
- 4. The schedule of outbound operations is from 04.06.2022 to 03.07.2022 and the return phase is scheduled from 15.07.2022 to 13.08.2022.
